

## **SUMMARY ANNUAL REPORT**

This is a summary of the annual report of the RURALMED LIFE, DISABILITY AND WORKSITE BENEFIT PLAN, EIN 47-2365020, Plan No. 504, for period 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with UNUM LIFE INSURANCE COMPANY OF AMERICA to pay Life Insurance, Short-term Disability, Long-term Disability, and Accidental Death and Dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$18,098.
